Introduction

The Office of the State Comptroller (OSC) has been updating the Justice Court Fund's (JCF) systems and processes. As an initial step, our efforts have focused on transitioning the monthly filing in the Justice Court Fund Internet Reporting (JCFIR) system to a new web-based application in OSC's Online Services portal called Justice Court Fund Reporting (JCR).

We are pleased to provide you with the Justice Court Fund Reporting-User Guide for Town and Village CFOs. In the event that a justice goes out of term without filing their monthly report or becomes incapacitated, CFO's should use JCR to inspect the justice's dockets and file the report with OSC. This user guide will assist you in filing these monthly reports within JCR.

We will continue to work to improve the user experience through additional modernization efforts and future business process improvements, but for this initial update, no changes have been made to invoicing and remittance of payments. Justice Court Fund Reporting

Town and village justices, including associate village justices and temporary justices, are required to report court activities on a monthly basis to the Office of the New York State Comptroller (OSC) Justice Court Fund (Uniform Justice Court Act, Section 2021; Town Law, Section 27; Village Law, Section 4-410).

As your local government's chief fiscal officer (CFO), OSC's Justice Court Fund (JCF) unit will continue to require your assistance with the submission of any not-filed reports by inactive justices in your municipality. As you are aware, until our office receives not-filed reports, your municipality is unable to recognize its due share of court revenues collected by your justices in the months at issue. Moving forward, you will need to file any such reports through the Justice Court Fund Reporting (JCR) application in OSC's Online Services Portal.

Accessing JCR

As the CFO, you have access to JCR in OSC's [Online Services Portal](#) using your current Online Services user ID and password.

If you have forgotten your Online Services password or if your account is locked, please contact OSC's Local Government Help Desk at 1-866-321-8503, option 1 or LocalGov@osc.ny.gov.

JCR will be visible under your list of available applications or from the "Apps" drop down menu in the banner.



CFOs can only view reports that require CFO assistance. To file a report, you will need to do the following:

- Inspect the Justice's docket.
- Review any cases disposed of during the month.
- Submit the monthly report through JCR.

Actionable Reports Screen

Upon launching the application, the default display shows all inactive justices in your municipality with past due reports that are required to be filed.

Report Status Descriptions:


- **Not Started:** The report is available for filing but has not been started. Selecting the “Start Report” button will change the status to Started and the date will get recorded as the Prepared Date.
- **Started:** The report has been started but not certified. Selecting the “Certify Report” button will, if successful, file the report with JCF, change the status to Certified and the date will get recorded as the Certified Date.
- **Refiling Required:** The report was previously certified and submitted and the status was then changed to Refiling Required by JCF staff. This is typically done when errors are identified during review. The report is considered not filed until recertified and resubmitted.

How to Submit a Report

A justice’s monthly report is due for every month they are in term, regardless of whether the justice has heard any cases.

JCR requires that AC-1030s be filed as text files. We cannot accept or process reports in a PDF file format.

From the [Actionable Reports](#) screen, select the “View” button next to the report month and year you wish to file. You will be directed to the “Report View” screen and can then select the “Start Report” button.



Submitting your Report

1. Indicate financial activity:
 - a. Check the “No Money Remitted (No Money Report)” box if no money was turned over to the CFO for the report month. If this box is selected, the “Report Amount” and “Date Check Sent to CFO” boxes will become greyed out and no entry will be required or
 - b. Enter the “Report Amount,” which must match the check total turned over to the CFO, and the “Date Check Sent to CFO,” which must be today’s date or prior. (See a sample screen on the next page.)
2. Browse and select, (or drag and drop) the report file from your computer. A preview of the report displays; confirm this is the report you wish to upload. You can double click the report to view it in further detail.

3. Select the “Save and Continue” button.
 - a. If you receive an error and are unable to upload the report, see [Reporting Errors](#).
4. If your report contains an adjustment, verify that the adjustment amount displayed is correct and provide the necessary information in the “Adjustment Explanation” box. To help organize the details of the adjustment(s), the list of requested information should be copied and pasted into the “Adjustment Explanation” text box. Once the adjustment information has been entered select “Save and Continue.”
5. JCF staff will review the information provided and if needed request additional information. Submitting incomplete information may result in delays when processing your report.
6. Ensure the information in the “Summary” box is correct. If changes are needed, select the “Cancel and Start Over” button.
7. If no changes are needed, check the certification box and select the “Certify Report” button.
8. A confirmation message is displayed: select “OK” to certify the report or “Cancel” to make changes.

Troubleshooting: Reporting Errors

While submitting your report, you may receive one of the following error messages:

Report Submission Error	Possible Cause	Resolution
Check Total on AC-1030 must be 0.00.	The check amount in the AC-1030 file does not equal 0.00 and you selected “No Money Remitted.”	Confirm that the report should have no money remitted. If so, attach the correct AC-1030 file with 0.00. If the report should have money remitted, then unselect “No Money Remitted” and enter the correct amount.
The Report Amount must be equal to the Check Total of the AC-1030	The Report Amount entered does not equal the check amount in the AC-1030 file.	Ensure the correct check amount figure is on both the AC-1030 file and entered in the “Report Amount” data box.
The Date Check Sent to CFO must be today or prior.	The date that the check was sent to the CFO entered in JCR was after the date the report is being filed.	Ensure the check was sent to the CFO before or on the report filing date and that the date selected is accurate.
AC-1030 file is required.	No file was selected.	Browse and select, or drag and drop the report file from your computer.
The AC-1030 contains formatting errors.	The wrong file type (i.e., a PDF or another document format) was selected.	Ensure the proper AC-1030 file is selected, and that the file extension is .txt.
The AC-1030 file name is not formatted properly. File naming convention is: ACYYMMCC.### (AC=Audit & Control; YYMM=year and month of report; CC=county code of court; ###= unique 3 digit justice number)	The information in the file name is either incorrect or in the wrong order. The Justice ID of the AC-1030 file does not match the Justice ID for whom you are filing for.	The Justice ID in the AC-1030 file does not match the Justice ID in JCR.	Verify the Justice ID in The CourtRoom Program matches the Justice ID in JCR and the correct file is attached.
The report period of the AC-1030 does not match the report period for which you are filing.	The report year and month (YYMM) in the AC-1030 file does not match the report selected in JCR.	Verify the report year and month on the AC-1030 file matches the report selected in JCR.

Manual JCR Filing


If you are set up as a manual JCR filer, it is because we were informed that the justice did not have access to The CourtRoom Program. Therefore, you will have to provide the monthly disposition information manually in JCR. If you are set up as a manual JCR filer but have obtained an AC-1030, contact JCF at 1-866-321-8503, option 2 or email courtfund@osc.ny.gov.

As a manual filer, you will have the option to file a “No Money Remitted (No Money Report)” and/or a “No Activity” report, or provide individual case details in an explanation box. An email will be sent to JCF containing “No Activity” or the details of the monthly activities in the explanation box. JCF staff will review the information provided and, if needed, request additional information.

On the [Actionable Reports](#) screen, select the “View” button next to the report month and year you wish to file. You will be directed to the “Report View” screen where you can select the “Start Report” button.

Manual JCR Filer: No Activity Report


1. Check the “No Money Remitted (No Money Report)” box. This makes the “Report Amount” and “Date Check Sent to CFO” fields no longer required.



2. Check the “No Activity” box. This makes the “Case Information” box no longer required.

3. Select the “Save and Continue” button.

4. Ensure the information in the “Summary” box is correct. If changes are needed, select “Make Changes.”



5. If no changes are needed, check the certification box and select the “Certify Report” button.
6. A confirmation message displays: select “OK” to certify the report or “Cancel” to make changes.
7. Confirm in the “Report” panel that the “Report Status” is now showing “Certified” and the certified date and name appear. You may print this page for your records. Please note that you will no longer receive an email upon submitting your report.

Manual JCR Filer: Activity Report

1. Indicate financial activity:
 - a. Check the “No Money Remitted (No Money Report)” box if no money was turned over for the report month or
 - b. Enter the “Report Amount,” which must match the check total turned over to the CFO, and the “Date Check Sent to CFO,” which must be the current date or prior.
2. Since there is activity, do not check the “No Activity” box.
3. Enter the [Case Information details](#) into the text box. To help organize the case information provided, the list of requested information, along with the associated number, should be copied and pasted into the “Case Information” text box. JCF staff will review the information provided and if needed request additional information.
4. After the case information has been entered, select the “Save and Continue” button.
5. Ensure the information in the “Summary” is correct. To view all the case information, you can scroll.
6. If changes are needed, select the “Make Changes” button.
7. If no changes are needed, check the certification box and select the “Certify Report” button.
8. A confirmation message is displayed; select “OK” to certify the report or “Cancel” to make changes.
9. Confirm in the “Report” panel that the “Report Status” is now showing “Certified” and the certified date and name appear. You may print this page for your records. Please note that you will no longer receive an email upon submitting your report.


